
Dreamers live in a waiting game where they do not know if at any moment this program could be taken away from them and the life they built in the United States goes away.

DACA

- Dream Act of 2001
- Barack Obama: DACA (2017)
 - Deferred Action for Childhood Arrivals
- "Dreamers"
- Benefits
 - A work permit, licensing, school attendance, and protection from deportation.
- They cannot receive amnesty, a path to citizenship, voting or federal benefits such as food stamps, financial aid and health coverage through DACA.


