Each faculty advisor meets individually with every student at each of the 4 admissions and retention "Gates." Interaction in these meetings ensures that the teacher education student and program meet the assurances listed above. Also, members of the teacher education program participate in an "Action Plan" meeting every academic year, where data are examined and interpreted, decisions about the program are made, and student performance is discussed. At this meeting, such assurances are examined and discussed. All students are required to take a specific course in teaching students from diverse populations and with exceptionalities. These assurances are included in our official evaluation forms.

Multiple technology projects are intentionally woven throughout the education curriculum, a strategy that allows teacher candidates to use instructional and informational technologies within a meaningful context. All EPP faculty believe that candidates will incorporate technology in more authentic and meaningful ways if they are expected to use technology in their own teaching and learning. We emphasize the use of SmartBoard technology in our methodology classes. To facilitate this we developed a framework that helps focus our conversation. In our introductory methods classes, when students are designing their initial lesson plans, we focus a specific assessment rubric on their use of technology to enhance the lesson design. With the help of our technology team in the department we pulled together a draft rubric that we can use as a starting point to have this conversation. There are components in PRECPAST that also hit on these topics. We repeated the same process for lesson design in the student teaching experience. Supervisors would assess one of the lesson plans taught during student teaching with the same technology enhancement rubric. I like this as a means to close the circle we start in the early methods. There are components in CPAST that also hit on these topics. The department will utilize the SAMR model for utilizing technology in our courses.

The Department of Education at The College of Wooster requires that all Elementary and Adolescent to Young Adult candidates to enroll in and successfully complete the following course prior to program completion. EDUC17000-Introduction to Intervention and Student Support. This course is designed to explore the federal government's exceptionalities categories and special education models currently used in schools. Emphasis is placed on the following topics: laws governing special education; research-to-practice gap; disproportionate representation in special needs classrooms; the impact of ELL/ESL; at-risk students; collaborations with colleagues and students' families; instructional differentiation; early intervention; problem-solving; writing and interpreting the IEP; cultural diversity, and Dyslexia. The course includes a 20-hour field placement/speaker series to learn more about a special needs program. In addition, all students must take EDUC300-Classroom Management as Social Justice. This course examines topics relevant to all teachers. Guest speakers from local schools and agencies are integral to both courses. Although these courses focus primarily on the preparation of general education teachers, they are designed specifically on how to teach students with disabilities. In addition to these specific courses, the majority of courses throughout the education program integrate numerous lessons and specific practices and principles with the same focus.
